Volunteer Positions Available:

Timekeepers

- You will be designated a specific courtroom and a panel of judges
- You will be responsible for monitoring the time for each speaker's submissions and will indicate the last minutes of time (5-3-1)
- You will be responsible for maintaining order in the mock court
- Note: The Paralegal Cup runs on a very strict schedule. This position plays a key component and requires volunteers who are focused, confident and comfortable taking command of a room of people.

Runners

- You will be responsible for collecting score sheets from the judges after each round of competition
- You will promptly return them to the registration desk so the round scores can be tallied and the next round of pairings can be organized
- Note: The judges enjoy giving lots of feedback. While we encourage this, we will ask you to work with the timekeepers to ensure that the scores are retrieved as quickly as possible to keep the day's schedule on track.

Judges' Assistants

- You will serve as a personal assistant for our invited judges
- You will be stationed in either their chambers or courtrooms to ensure they have everything they need throughout the day
- This could involve: water refills, tidying, running communications from judges to the organizers, etc.

Greeters/Ushers

- You will be responsible for welcoming attendees, guiding them to specific locations and answering questions or concerns
- You will be needed in the morning, throughout the day (for late arrivals) and at night to assist with the seating chart for dinner on Saturday
- You will need to be comfortable speaking in a professional manner to a wide range of individuals

Coat Check Attendants

- You will be responsible for collecting, organizing and monitoring the personal belongings of participants and guests
- Our special guests in the past have brought sensitive and privileged information along with them and need to be able to access it throughout the competition
- Note: This position will be done in shifts .You are welcome to bring any reading/homework you need to complete during your shift

Set-Up/Teardown Coordinators

- You will be responsible for setting up and tearing down L Building for the weekend of competition
- This includes: removing tables and chairs, setting up/tearing down the stage, staging the floor plan for the formal dinner, printing/organizing documents, etc.
- Note: This position requires a lot of physical activity. You must wear clothing and footwear that you feel most comfortable moving around in.

Note: Your assigned position may change throughout each day due to varying circumstances (timekeepers not included). Each year, new tasks present themselves that need to be addressed throughout the competition and we ask for your flexibility in meeting and accommodating these needs.
